Introduction

The National Health Service (Scotland) Act, 1947, set up Regional Hospital Boards and, within them, Boards of Management responsible for the administration of groups of hospitals. This system operated until the reorganisation of the National Health Service in 1974.

The Board of Management for the Edinburgh Northern Hospitals formed part of the South Eastern Regional Hospital Board and consisted of the undernoted hospitals. Reference numbers in brackets refer to pre 1948 records of these hospitals: as many of the hospitals in this group were originally municipal hospitals, references to them will be found in the records of Edinburgh Corporation's Public Health Department (LHB27).

From 1974 to 1984 these hospitals formed part of the North Lothian District of Lothian Health Board (*see* LHB27).
